**Parental Release for PG Rated Movies:** Throughout the summer, we may show a PG (Parent Guidance suggested) movie. Parental Guidance is defined as some material may not be suitable for children". This signifies that the film may contain some material parents might not like to expose to their young children. Explicit sex scenes and scenes of drug use are absent in PG movies. Nudity, if present is seen only briefly. Horror and violence do not exceed moderate levels. Examples of PG movies are "Like Mike", "Shrek", "Shrek 2", "Daddy Day Care", "Holes", "pink Panther", "Charlie and the Chocolate Factory", "Madagascar", "Robots", "Because of Winn Dixie", "Racing Stripes" and "Good Boy". If you would not like your child to watch PG movies, they will be provided with an alternative activity outside of the movie viewing area.

## Neighborhood House, Inc. Summer Enrichment Program – Behavior Code

All campers and parents must sign that they have read and understand the behavior code and discipline consequences of the Neighborhood House, Inc. Summer Enrichment Program.

We expect all campers to respect the teachers, staff, counselors, fellow campers and themselves. Disrespect of any supervising adult or counselor will not be tolerated. The first offense will result in a verbal warning, the second offense will result in a written warning, and the third time will result in the camper losing the privilege to participate in the next field trip or special event.

All students are expected to participate in all academic activities. We expect that all campers will try to start and complete academic tasks that they are given. We will try our best to place students in grade appropriate groups.

All students are expected to participate in whole and small group activities. Small and whole group activities may include basketball, kickball, relay races, musical chairs etc.... Campers will go outside at least once a day and sneakers are required for them to participate.

Demerits will be given to students who do not participate in academic and whole group activities. Any camper that receives 5 demerits in one week will not be permitted to attend the next field trip or special event. Demerits will be given for non-participation in academic and whole group activities or unacceptable hallway behavior.

The Neighborhood House, Inc. hosts many programs and has visitors throughout the day. Keeping this in mind we ask that all campers are escorted to and from all locations with appropriate hallway behavior. Acceptable hallway behavior is campers that walk quietly in the hallway, laughing, giggling, running and screaming are unacceptable and those students will be given a demerit for each offense.

Behaviors which cause injury to others or significant property damage are grounds for immediate dismissal from the Summer Enrichment Program. Major behavior problems are:

- Hitting, fighting, biting, or bullying
- Stealing
- Vandalism
- Possession of any type of weapon
- Hitting any adult or counselor

Major behavior problems will be managed in the following ways:

**1<sup>ST</sup> Incident:** Parents will be called in for a conference with child and Program Administrator. Child will not be allowed to attend until the conference takes place.

**2<sup>nd</sup> Incident:** Parent will be notified and another conference may be scheduled. Child may be dismissed from the Summer Enrichment Program.

If a child misbehaves on a field trip, he or she will not be permitted to attend the following trip. In the event of a behavior which risks or causes injury to other individuals or themselves, the child may be dismissed from the Program or prohibited from taking any future field trips.

**Dress Code:** All campers are required to wear sneakers to camp every day. In addition, campers will participate in activities that require them to sit on the floor/ground, because of this we ask all campers to wear comfortable clothing.

**Water Play:** A bathing Suit and a towel need to be brought on swim days. Bikini type bathing suits will not be permitted for swim and trip days. Any camper that brings a bikini bathing suit will not be permitted to swim that particular day.

**Neighborhood House, Inc. Summer Enrichment Program – Health Policy**

**Health Policy:** Keeping your child healthy is important to both of us. By working together we can keep your child healthier. Children with temperatures over 101 degrees Fahrenheit, uncontrolled diarrhea, vomiting or any other illness listed below should not be in summer camp. Child care requirements require me to follow this policy. These requirements were developed directly from guidelines set by the American Academy of Pediatrics and American Public Health Association.

If your child becomes ill during the day, I will have to call you to come pick up your child promptly.

I will encourage your child's good health by serving nutritious meals and teaching good hygiene to the children, especially hand washing.

I will supervise your child closely in an attempt to prevent injuries, but accidents resulting in minor injuries do occur. I have been trained in first aid and CPR and will follow my training. If the situation is serious, I will call you and may even suggest that you take your child to the doctor or the emergency room. If an injury is very severe, I will call 911 for assistance before I call you. If I cannot reach you, I will call the emergency contact person listed on your child information card.

It is also essential that you tell me if your child has been exposed to a contagious illness, such as chicken pox or strep throat, so I can watch for symptoms of the illness in your child and other children in care.

**Neighborhood House, Inc. Summer Enrichment Program – Payment Policy**

**Payment Policy & Agreement**

- Price for one child is \$120 per week for ages 5 through 12 years old.
- Your Payment Agreement must be signed prior to the start date.
- A service week is 4 or 5 days from Monday to Friday.
- Payment for a new week is due the Friday before.
- Payments are due each Friday unless another schedule is agreed upon.
- There is a penalty of \$10 applied to payments made late without prior arrangements (This is excluding the parents or guardian with POC Payment.)
- Payments can be made with money order or personal check. Payee is Neighborhood House, Inc.
- There is a \$15 penalty for a returned check.
- There is a \$10 late pick-up charge imposed after 5:35 pm and every 5 minutes thereafter.
- Field trips are included in the tuition. You will receive advanced notice of field trips, etc.
- Purchase of Care (POC) Agreement must be received before your child will be allowed to attend.
- Parent Fees for POC must be paid as stated in your POC Agreement. Non-payment of POC Parent Fee will be reported to the Division of Social Services.
